PROGRAM RULES

Eligible Program dates: Eligible Products purchased between October 1, 2006 and September 30, 2007 are eligible for the Partners Incentive Program.

Eligible Participants: The Partners Incentive Program is open only to Builders, Retailers and Service Companies in the Swimming Pool Industry; who are based and resell in the United States; who purchase the eligible products from an authorized U.S. pool supply distributor at regular dealer prices.

Enrolling: To participate in the Partners Incentive Program, simply complete all information on this “Enrollment Form” and return a copy via fax. Once enrolled, you’ll receive a confirmation and member dealer number.

Eligible Products: The list of eligible Pentair equipment models is too long to list here. Please see separate “Eligible Products” form for a complete list.

Minimum Purchase for Eligibility: You must purchase a minimum of 20 Eligible Products (any combination) to begin receiving rewards, and when purchasing four or more product categories, your reward increases.

For those enrolling in the Cleaner Only Program, the minimum purchase of eligible cleaner products is one.

Reporting Your Purchases: Products must be purchased through an authorized U.S. pool supply distributor. Signing your “Enrollment Form” will authorize us to receive your purchase detail directly from those distributors participating in the electronic exchange process. If your distributor does not participate electronically, you will need to submit your invoice copies directly to us for reward calculations.

Redeeming Your Rewards: Rewards are redeemed by submitting the “Partners Incentive Program Redemption Form” available at the close of the program year.

After accumulating purchases of 20 Eligible Products (or one eligible cleaner), your rewards apply retroactively to the first unit purchased. Rewards must be accumulated by September 30, 2007 to qualify for trip. All rewards expire at midnight on December 15, 2007 and may not be carried over to the following year.

GENERAL RULES

Rewards earned are based on purchases of Eligible Products less all returned Eligible Products.
